# Great Texas Mosquito Festival GrillMaster

## Rules and Regulations

This event will be based on the Iron Chef competition. The winner will be crowned GTMF GRILLMASTER for the year. There will be a minimum of ten or a maximum of fifteen competitors in this event. Get your entry form in early. There will be a separate entry fee of \$25.00 for this event to be collected when your name is called at the chief cooks meeting on Monday July, 20<sup>TH</sup> 2009. If you really want to compete, make sure you are at the meeting. If you are not present when your name is called your slot will be given to the next entrant in line.

1. The Cook-off committee will provide 1 grill and heat source, such as charcoal or wood for each entrant. You will only be allowed to use the grill and heat source which is provided to you by the committee. Everyone will be provided with identical supplies.
2. The secret ingredient will be provided by the committee beginning at 6:30 p.m. on Friday night and will be distributed in 5 minute intervals to teams. You will have a designated time frame from the start horn to complete and plate your dish(es). You will be allowed to make ONE trip to your camp for supplies such as seasonings and utensils. You will be provided a container to transport your items from your site to the contest area. All seasonings, sauces, garnish, ingredients must fit in this container, no exceptions, and if it will not fit you can not bring it in. Cooking utensils will not be required to fit in this container. All ingredients must be in whole, uncooked form, example, No pre diced onions, sliced fruit, etc.... The only exception to this rule is if it was purchased from a store in that form, and still in its original sealed packaging.
3. Dishes for plating will be provided by the committee, everyone will have access to the same dishes.
4. There will be one cook and one assistant allowed per entry. Must already be a registered team member in the cookoff.
5. Judging will be based on Taste, Presentation, Aroma, and Originality.
6. All cooking and prep must be performed at the judging pavilion; you will be in the view of everyone, no secrets here, other than the main ingredient. The main ingredient will not leave the contest area.
7. Although this is a separate event, you must be entered in the Main cook-off to be entered in this event. This event will not go towards overall points.
8. Judging will not be blind and will be judged by the committee or their representatives.
9. The Cookoff Chairman reserves the right to make additional rules as the situation warrants. Decisions of the Cookoff committee and judges are final.

# GRILLMASTER ENTRY FORM

## **GRILLMASTER TEAMS MUST ALSO BE REGISTERED IN THE COOKOFF TO BE ELIGIBLE TO COMPETE.**

UPON REGISTRATION YOUR TEAM WILL BE LISTED AS ELIGIBLE. TEAMS WILL BE CALLED IN THE ORDER IN WHICH THEY WERE ENTERED. A MINIMUM OF TEN OR A MAXIMUM OF FIFTEEN TEAMS WILL BE ELIGIBLE FOR A CHANCE TO PAY THEIR ENTRY FEE OF \$25.00 AND COMPETE IN THE GRILLMASTER COMPETITION.
